Definitions and interpretation

User or you	any third party that accesses the Website and is not either (i) employed by Portia Partnership Savings Club Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Portia Partnership Savings Club Ltd and accessing the Website in connection with the provision of such services; and

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Portia Partnership Savings Club Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

How we collect Data

- 6. We collect Data in the following ways:

 - b. data is collected automatically.

Data that is given to us by you

- 7. Portia Partnership Savings Club Ltd will collect your Data in a number of ways, for example:

Data that is collected automatically

Our use of Data

Data retention

Your rights

- 18. You have the following rights in relation to your Data:

 - c. **Right to erase** the right to request that we delete or remove your Data from our systems.
 - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. **Right to data portability** the right to request that we move, copy or transfer your Data.
 - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
